# MACRO ECONOMIC UPDATE



### GLOBAL

- The monetary policy actions of global central banks continued to dominate headlines in the month under review as they appear undeterred in their fight against elevated inflation readings. Although, headline inflation moderated in US for the second consecutive month, declining by 20 bps to 8.3% y/y for August and UK inflation slowed to 9.9% y/y in August from 10.2% in July, nonetheless, their respective central banks marched on with rate hikes to further moderate inflation. Accordingly, U.S Federal Reserve raised rates for the third consecutive time by 75 bps while the Bank of England (BOE) increased the key policy rate for the seventh consecutive time by 50bps to 2.25%.
- Meanwhile, recession fears ignited by aggressive rate hikes and worries about China's economic strength pushed oil prices lower. For context, Brent crude oil prices declined by 8.6% m/m to an average of \$90.16 (August: \$98.60). The UK's economy came under spotlight at the tail-end of the month as the announcement of outlandish tax cuts and plans to increase government spending by the Minister of Finance drove widespread sell-offs in the country's financial market. However, some calmness returned after the Bank of England announced its intention to buy back UK gilts.
- It was yet another turbulent month for global stocks as aggressive rate hikes by central banks and its attendant impact on economic growth undermined appetite for risk assets. In the US, DJIA and S&P plunged by 7.25% and 7.95% month-on-month respectively. Similarly, the European markets suffered losses as FTSE (-5.30% m/m) and Stoxx 600 (-7.14% m/m) fell sharply in September. MSCI Emerging Markets Index also declined significantly by 12.15% m/m while MSCI Frontier Markets Index shed 9.21% m/m.

#### **DOMESTIC**

- The composite PMI rose to 53.7 in September from 52.3 in August, signalling an improvement in private sector activities despite elevated inflationary pressures and FX liquidity challenges. The increase was underpinned by strong increases in outputs and new orders. However, there was a notable increase in backlogs of work due to challenges faced by manufacturers in securing funding needed for production activities.
- Headline inflation rose further by 88 basis point to 20.52% y/y in August (July 19.64%), on the back of persistent pressures across the food (+110bps) and core (+94bps) baskets. Food inflation accelerated to 23.12% YoY, due to the combined impact of security challenges in food producing regions, elevated input and associated logistics costs. Similarly, core inflation rose to 17.20% y/y due to the knock-on effects of elevated energy prices, rising commodity prices and liquidity challenges in the FX market.

# FINANCIAL MARKET UPDATE

### **EQUITIES**

- The local bourse recorded a loss for the fourth consecutive month in September as investors' appetite for stocks remained weak due to expectations for sustained uptick in Fixed Income yields. Overall, the All Share Index declined by 1.63% m/m while the year-to-date performance moderated to +14.77% (August YTD:+16.67%).
- Given the absence of positive triggers in the macro space and corporate actions, domestic investors who are the dominant market players continued to rotate funds to the FI market to take advantage of attractive yield offerings.
- The bearish performance of the market was driven by losses in large-caps- NESTLE (-10.00%), GTCO (-9.19%), and ZENITH (-7.30%). Sectoral performance was also negative as the Insurance index (-6.45%) recorded the biggest loss followed by Oil and gas (-4.49%), Consumers (-2.64%), Banking (-2.12%) and Industrials goods (-1.63%) indices.

## **FIXED INCOME**

- Bearish sentiment prevailed in the fixed income market, as supply outweighed demand amidst tight system liquidity, increased CRR debit, FX retail auction and higher inflation numbers. In addition, the 150 bps hike in MPR by the MPC at the latter part of the month further supported the northward trend of FI yields.
- The Treasury Bills market reflected opposing movement at the primary and secondary markets. While average yield advanced by 213 basis points month-on-month at the primary market, the average yield at the secondary market declined slightly by 23 basis points as demand for short-dated instruments increased due to expectation of further yield widening. At the last NTB auction in September, the 364-day instrument closed at a stop rate of 12.0% relative to 9.75% and 10% earlier in the month.
- At the September bond auction, the DMO re-opened the 2025, 2032 and 2037 maturities. Participation level was slightly lower when compared to the August auction as bid-to-cover ratio declined by 0.1 points to 1.1x. Average stop rate at the auction advanced by 60 basis points to 13.93% relative to August. Similarly, average yield at the secondary market for bonds advanced by 31 basis points in September relative to August.





### **FUND STRUCTURE**



# **OUTLOOK**



### **GLOBAL MARKETS**

In line with the trend observed over the past six months, we believe the movement in asset prices and outcomes in the global macro space would remain centered around the monetary policy actions of global central banks and geopolitical tensions. In the oil market, the unexpected and large production cut of 2 million barrels per day instituted by OPEC+ would likely provide support for oil prices offsetting concerns about weakening demand due to recession fears. As a result, we see scope for brent crude oil prices to trade above the \$90 mark in the month of October. Given this, we expect inflationary pressures to persist in the Eurozone premised on elevated energy prices combined with tepid supply from Russia via the Nord stream pipelines. As such, we envisage that economic activities in the region would remain hampered by energy challenges. In the US, we think investors will be paying rapt attention to labour market data for signs of a broad slowdown in the economy. Overall, we expect volatility to continue to permeate across financial markets as investors attempt to strike a difficult balance between recession risks and the hawkish rendition among global central banks.

#### **DOMESTIC MARKETS**

### **EQUITY**

With the third consecutive hike in MPR by the CBN's MPC at its penultimate meeting held in September, we expect market sentiments to remain underwhelming as investors continue to rotate funds towards the FI market in search of attractive returns. We envisage that the 500 bps hike in CRR to 32.5% would drive negative reaction to banking tickers given the negative impact of the policy on Net Interest Margins and by extension profitability. Although, Q3 2022 corporate earnings would be released shortly, we expect muted reaction to the results given relatively higher FI yields. Furthermore, as political activities take center stage in the build-up to the general elections in February 2023, we expect growing uncertainties among investors to undermine appetite for risk assets whilst FPIs continue exhibiting cold feet towards naira assets given persistent FX liquidity constraints, increased political risk and rising global FI yields.

# **FIXED INCOME**

The fixed income market is expected to remain bearish on the back of the unabatedly high inflation rate, and the upward revision of the MPR, which are both expected to keep rates elevated at both the primary and secondary markets for Treasury Bills and Bonds. Given the lower maturity level expected in October, tight system liquidity may also support the bearish sentiment as the DMO continues to borrow at decent levels amidst weak demand. The MPC is also expected to maintain its hawkish stance for the rest of the year with the expectation that the surging inflation rate will be brought under control, gap in negative real interest rate reduced while capital flight from the economy is moderated.
