ARMIM and our Buyer Agents also work with Clients who require referrals and introductions to Tax Advisers, Accountants, Solicitors, Financiers and more in respect to real estate assets.

What is ARMIM's role?

ARMIM created an operational Desk with local staff and UK based staff for the purpose of developing and smoothly delivering this Service exclusively to ARMIM Clients. The UK Buyer Agents collaborating with ARMIM do this premised on the trust and expectation that ARMIM Clients have been through a standard KYC and due diligence process and therefore fit the calibre and profile of their ideal Clients. What documents will be provided by interested Clients?

Depending on whether the transaction is a sale or purchase mandate and if the Client is desirous of a mortgage facility, these are standard documents that our clients usually need to provide:

- Standard KYC documents
- Acceptable form of Identification
- Proof of Address within the last three months, (must be signed by a Notary Public)
- Payslips (to provide earning credibility)

- Employment confirmation letters or monthly and annual income confirmed by Account Officer
- Statement of Net Worth endorsed by a chartered accountant (a document that fulfils a broad range of requirements such as Investment and bank statements, tax returns, evidence of rental income from investments property owned and more may be required)
- Evidence of source of funds to support all financial and investment statements provided.

FAQ

Is ARMIM or the UK Real Estate Company charging any additional fee for this Service?

No; the fees stated above are the only fees due directly for the Service, ARMIM and the UK RE Company will not charge any additional fees. There are however other charges and costs involved in the process which will be paid to the professionals/companies engaged to provide these additional services.

Does the Service include arranging Mortgages?

Yes; while ARMIM does not provide mortgages or financing directly; we work with UK Mortgage Brokers experienced with working with International and Nigerian clients. These Mortgage Brokers provide guidance and a service to Clients to ascertain their borrowing potential and secure finance against assets in the U.K, in Nigeria and other countries abroad. These Brokers typically work with hundreds of UK Lenders, from high street banks to Private Banks, Bridging Lenders, Development Finance providers and other specialised Financial institutions, therefore have access to a broad spectrum of financing options to suit a Client's needs and profile.

What are the standard borrowing costs?

Borrowing/Mortgage costs will vary depending on the Mortgage Broker, the Lender, the profile of the Borrower, the terms of the Ioan and the LTV (Ioan to value) ratio being used. Typically, Mortgage Brokers would charge about 1% of the Ioan amount borrowed as their Advisory fee, which is separate from any costs or charges that the actual Lender will apply. Lender may charge a 1% arrangement fee in addition to other charges. Full details and comparative options will always be provided for Client's consideration.

What LTV (loan to value) ratios are usually applied for International Buyers?

Though each Client's case will vary, usually 60–75% of the asset value would be considered for an international buyer but Clients with a UK Residency status may be able to get financing up to 95% LTV ratio. This means for international buyers, self-funds in the region of 25-40% of the asset value should be available when considering a Mortgage; Clients need to keep in mind that this is in addition to all other established and potential costs and charges.

What are the other primary and associated fees & costs with UK RE transactions?

There are statutory charges and other potential expenses involved in the UK Real Estate purchase or sale process, which include:

When Buying:

- Mortgage and financing costs
- SDLT Stamp Duty Land Tax (Predetermined based on SDLT)
- Conveyancing (Solicitor's fees)
- Valuation fees (Valuation of property)
- Surveyor's fees (Survey report of internal and external aspects of property)
- Financing costs (Mortgage broker charges, mortgage/loan fees)
- Service charges (If applicable to property)
- Tax Advice (if required or advisable to get)
- Insurance (If required)
- Maintenance and repairs (If required)
- Council Tax
- Renovation, decoration and furnishing.

When Selling:

- Conveyancing (Solicitor's fees)
- Valuation fees (Valuation of property)
- Surveyor's fees (Survey report of internal and external aspects of property)
- Renovation costs (if needed or advised to undertake)
- Removal costs

FAQ

What property purchase options are available?

Clients may buy properties in their personal names, joint names, using SPVs, Trust Vehicle or Offshore companies held in BVIs. We advise clients to always consider and seek tax advice to establish the best suited purchase options when buying U.K. property.

What is the processing time for completion of purchase/sale?

Each sale or purchase is unique based on each Client's requirements, the conditions in the real estate market at the time, Client's readiness with provision of documents required, availability of funding and a whole lot more; but generally, a mandate can be fulfilled between 3-12 months. Notwithstanding the stated timeline, kindly note that mandates may be fulfilled outside this range.

Do Client's UK RE asset reflect in their ARMIM portfolio?

UK Real Estate assets are not reflected on the ARM portfolio management system and will not show in Clients' periodic reports. The exception is in cases where a Trust or Special Purpose Vehicle (SPV) managed by ARM Trustees Limited acquires the real estate asset and therefore have the asset included in the Trust portfolio reports.

What reports do Clients receive for property that is purchased as an investment/rental property?

The UK Buyer Agents will provide periodic reports on Clients' properties, and these will be sent directly to the Client or Company/Trust Vehicle Trustees, as appropriate.

Can a Client purchase or let property independently of this UK Real Estate Service?

Clients who enter a separate lettings & management contract with either ARMIM's UK Buyer Agent Companies or other independent Real Estate Agent Companies need to keep in mind that this is a separate mandate and arrangement, which is independent of the ARMIM UK RE Service. This will require a separate scope of service, separate fees and contracts.

How do Clients get timely updates on U.K. Real Estate opportunities?

Clients are usually initially introduced to this Service via their Relationship Managers (RMs) and those who express interest are included on ARMIM's UK Real Estate mailing list, where opportunities are shared periodically and as they arise. Clients receive updates on new and future real estate developments in different areas of the U.K and have priority access to consider properties being sold by other clients and related parties.

Consequently, Clients who subscribe to our real estate service mailing list are positioned to take advantage of opportunities, even when not actively looking to buy property.

What are the steps for an interested Client to take?

Below is a summary of the steps our Clients typically take:

- 1. Client contacts their RMs to express interest & have initial discussions.
- ARMIM sends Client a batch of introduction documents (Introduction letter, Buyer/Seller Requirements form, FAQ document); Client will need to complete and return the Buyer/Seller Requirements form.
- 3. ARMIM will arrange an initial meeting with the Client and the assigned UK RE Agent Company to discuss the Client's requirements and provide more information on the Service.
- 4. 4. With the receipt of all necessary paperwork and KYC documents from Client as confirmation of consent to proceed with the service, Client pays the initial commitment fee + UK VAT and completes the engagement documents for the UK RE Agent company handling their mandate.
